John Parsons introduced Mike Keller, newest appointed PCTC board member.

REPORTS TO COUNCIL

<u>9 CLOUD PRESENTATION ON PREVIOUS AND FUTURE MARKETING EFFORTS - MARY LYNN</u> BRADSHAW, OWNER

Mary Lynn Bradshaw presented market trends, funding issues and working with PCTC for future efforts. She also mentioned improvements made in 2024, East Yellowstone Valley Chamber of Commerce's analytics and website performance.

EAST YELLOWSTONE VALLEY CHAMBER OF COMMERCE UPDATE - MIKE CHRISTIANSEN, PRESIDENT

Mike Christiansen gave an update on the ranches of the East Yellowstone Valley Chamber.

<u>EAST YELLOWSTONE VALLEY CHAMBER OF COMMERCE - BOB RICHARD, PREVIOUS RANCH</u> OWNER & PCTC BOARD MEMBER

Bob Richard shared his appreciation of the North Fork and the ranches.

RECAP OF MEETINGS WITH RYAN HAUCK, JOHN PARSONS AND EYVCOC - JOHN PARSONS, CHAIRPERSON

John Parsons discussed frustrations working with the East Yellowstone Valley Chamber because of lack of communication and the uphill battle because of it.

VERB DISCUSSES BRINGING RANCH MARKETING IN-HOUSE - ANDY MACLELLAN

Andy MacLellan mentioned numerous opportunities for May Lynn Bradshaw to create for the ranches. He discussed everything he cad do internally as well as offered to meet with the ranch owners in person when he's in town this fall.

PAC UPDATE AND FUNDING REQUEST – JENNIFER THOMA, CODY CHAMBER OF COMMERCE EXECUTIVE DIRECTOR

Jennifer Thoma gave a brief update on the Cody Country PAC, discussed signage and fundraising.

MARKETING REPORT & UPDATE ON NEW WEBSITE - RYAN HAUCK, EXECUTIVE DIRECTOR

PROJECTS/PROGRAMS/FAMs/FILM/MEDIA:

Adeina Anderson will visit Monday, Sept. 2 – Friday, Sept. 6 to gather material for "100 Things to Do in Cody Before you Die" as well as for fall travel segments for her six television markets in Denver, Indianapolis, Austin, San Antonio, Richmond, and Tampa. Adeina is calling this the "Fall in Love with Cody" campaign. She will do three live segments in Denver, Austin and Richmond and taped segments in Tampa, Indianapolis, and San Antonio. She will also develop social media posts, reels, and magazine stories. We provided them with a list of restaurants that we would like to showcase including Trailhead, Pat's, Cody Steakhouse, Sitti's Table. Activities will include all-day fishing with North Fork Anglers, YNP day, Cody Firearms Experience, and two-hour trail ride with Bill Cody Ranch. Adeina and Yvonne will also explore BBCW as well as an artist demonstration at By Western Hands.

John Parsons and I have met with Bob & Angela Coe at Pahaska Tepee, Mike Christiansen from Shoshone Lodge and Guest Ranch, Joel and Krystal Baum from Rand Creek Ranch, Diane Walker from Creekside Lodge, Matt Risacher from Absaroka Mountain Lodge, and Debbie Millard from Elephant Head Lodge. They discussed many of their concerns which seem to be cured with us taking their marketing and sales efforts inhouse, however, they would not agree. John and I hope that we will come to a solution by the end of this board meeting.

There has finally been some progression on the HVS Conference Center Demand Study. A contract will be signed within this month which will include a detailed plan of what we can expect. I plan on meeting with Forward Cody, Cody City Council, Powell Economic Partnership, and the Park County Commissioners to inform them of the details and encourage their involvement.

We hosted Mark Bedor to help with his current and future projects. Mark is the creator and host of Today's Wild West - a half-hour documentary-style TV series on all things Western, a three-time winner of the National Cowboy Museum's Western Heritage Award for Outstanding Western Lifestyle TV show. He has forty-five episodes air on PBS in ninety-one markets in thirty-two states and many other stations and platforms. He is in Cody Sept. 12 – 22 shooting stories for Today's Wild West including: Profile of custom leather shop Mercury Leather - interview set for 9-14-24 @ 9:30; Story on Buffalo Bill and the founding of Cody - why he chose this spot - why he created the town and built the Irma - and his continuing impact on Cody; The West and the world based on an interview with Buffalo Bill expert Bob Richard, and a tour of the Buffalo Bill Museum at the Center of the West. He is also shooting a segment for Today's Wild West on Blackwater Creek Ranch from 9-15 to 9-21. Sept. 21 he'll begin a story on Rendezvous Royale - filming events including the Quick Draw, Art Sale, and the Patron's Ball, as well as any other activity and events. We may also see some stories produced in Cowboy & Indians magazine as he is a longtime contributor to them.

We have been hosting quite a few groups from our connections at International Roundup from the Great American West including Evasions USA (French), Riksja Reizen (German and Dutch), Marco Vasco (French), Adventure World (Australia/New Zealand), and Voyageurs du Monde (French). Between them all they have visited over twenty partners and four lodging properties to bring future business our way in 2025 and beyond.

Devilstone Run, Visit Gillette, and Visit Sheridan, and Cody Yellowstone ran a COOP influencer campaign to showcase the Black to Yellow route, our All-American Scenic Byways, and must-dos along the way. This campaign was massively successful for very little spend on our side. The influencers and motorcycle media we used were Jess Noblick (@HerTwoWheels), Harvey Briggs (TheAwesomer.com and Roadrunner & Travel), Sarah Schilke (Women Riders Now), Jonathon Klein (Executive Editor from RideApart), and a high-level photographer to capture it all.

I have completed our FY2024 Tour Operator FAM which included nine individuals representing six companies. This was another huge success for our destination. We visited over thirty partners over 6 days, including one day that was dedicated to Yellowstone. We toured the county over five hundred miles and 85 hours during their time here. We have already seen bookings for next year from many of these operators with more on the way.

We completed our FY24 Audit. The report will be presented during our December board meeting.

Our office sent out seventy-nine packets to government agencies, regional and statewide stakeholders, and interested parties in regard to the Outdoor Recreation Study, aka, The Plug. This packet included a cover letter, a recap of all the studies, and the studies themselves.

The FY24 Annual Report is completed and will be sent to every Park County household next week. This report highlights our use of Destination Development Funds, SATW, our marketing focus over the year, tourism stats and lodging tac numbers, grant information, and other wins from our office.

I am working with Jesse Miller, Jake Scott (Sitti's Table), LeAnn Miller, Adam Amick, and Stacey Martin (Chamberlin Inn) to produce a farm-to-table event showcasing our local producers and Agri-tourism to the area. This event will take place in October, trying to extend our successful shoulder season later into the year. This will take a financial partnership on our end, but we will have content and an event to grow annually from this point on working with these partners.
